CONTRACT TERMS

AGREEMENT made this ____ day of _____, 200__, between the Client, who is:

and Ann's Video Connection of Wethersfield, Connecticut ("AVC"), as follows:

Client wishes to retain AVC for the purpose of video recording an event which is scheduled to occur on the ____ day of _____, 200__, at the following location(s):

Client agrees to pay the following amount to AVC, as derived from the schedule of charges of AVC which is attached: \$_____ (including applicable taxes).

One-third (1/3) of such amount is being remitted to AVC by the Client on the signing of this Agreement. The Client acknowledges that this amount is not refundable under any circumstances, except as stated below.

An additional one-third (1/3) of the above amount will be remitted to AVC on or before the date which is two weeks prior to the scheduled date of the event. The final one-third (1/3) of the above amount will be remitted within one month after such event occurs, and upon receiving such final payment, AVC will promptly deliver the finalized product to the Client.

Client agrees to keep AVC informed with respect to any restrictions or rules pertaining to videographers which are applicable in connection with any location where videography is to occur. AVC agrees to abide by such rules. Client acknowledges that it is the sole responsibility of Client to arrange for any variation or waiver of such rules, if any is desired. Written permission for such variation or waiver of rules, signed by an authorized individual, must be presented to AVC prior to the event; otherwise, Client acknowledges that AVC will observe the applicable restrictions.

Client agrees that AVC may make reasonable use of any footage shot at the event, for AVC's own promotional purposes, without compensation to Client.

Client acknowledges that AVC shall have no liability, beyond a refund of the amounts paid hereunder, in the event of an equipment failure or any other unforeseen event (involving matters under the sole control of AVC) which prevents the recording of the event. Otherwise, AVC will refund all amounts paid hereunder to Client if AVC is unable to perform because of illness, accident or otherwise and is also unable to obtain a replacement professional video service without additional cost to the Client. AVC agrees to give Client the earliest possible notice in such event.
